#### How we store your personal information

Your information is securely stored using MailChimp's secure 2-Factor Authentication servers and locally under AES-256 encryption.

We keep Email Addresses for 2 years. We will then dispose of your information by securely destroying any information we hold on you. We will also securely destroy any data we hold on you if you choose to unsubscribe from our mailing list.

## Your data protection rights

Under data protection law, you have rights including:

**Your right of access** - You have the right to ask us for copies of your personal information.



**Your right to rectification** - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.
